



# DOUBLE J RANCH STALLION SERVICE CONTRACT

(Does not Guarantee breeding until returned deposit.)

Double J. Ranch, agent for the above named stallion, will herein be referred to as Breeder.

This service is engaged subject to the following:

1. A booking chute fee \$500.00 of the above fee is payable with this contract, and the balance of \$ \_\_\_\_\_ plus all unpaid expenses will be payable upon receipt of an invoice or when mare leaves the farm, whichever is first. The mare (and foal, if applicable) shall be released only upon payment in full of outstanding invoices, including those from the attending veterinarian.
2. In the case of rebreed, a non-refundable chute fee of \$500.00 is payable with the contract and must be received by Breeder before any breeding or related procedures are performed on the mare. A rebreed will not be considered a rebreed unless any and all fees incurred in the previous season have been paid in full prior to the closing of said previous season.
3. A photostatic copy of registration papers (both sides), a veterinarian's health certificate, worming, immunization records, and a current Coggins test (within 6 months) shall accompany mare. If these are not presented upon mare's arrival, the Breeder shall have the attending veterinarian make proper tests and evaluations at the Mare Owner's expense, and mare will not be bred until these test results are in Breeder's possession. Mare (and foal, if applicable) will be periodically vaccinated and wormed as deemed necessary by the attending veterinarian at Mare Owner's expense.
4. Double J Ranch agrees to provide suitable facilities for the care and feed of the mare and/ or foal while in its custody. Mare owner agrees to the following rates; \$ \_\_\_\_\_/day pasture; \$ \_\_\_\_\_/day stall with exercise; foals with mares are \$2/day additional.
5. There is a \$ \_\_\_\_\_ charge for the first shipment of cooled transported semen, and a \$ \_\_\_\_\_ for each additional shipment. The stallion Fee including booking must be paid prior to any semen shipment.
6. Stallion collection schedule is Monday, Wednesday, Friday for the next day shipments of semen. All transported semen shipments must be scheduled prior to 9:30 am EST on collection days, no exceptions. Mares on premises have priority over shipped semen.
7. The Mare Owner agrees that each mare offered for breeding shall be in sound breeding condition and free from infection or disease. Any mare certified by the attending veterinarian not to be, in his opinion, in sound breeding condition shall not be bred. Mare Owner may substitute another mare within same breeding season.
8. The Breeder agrees to diligently try and settle the above named mare and shall have sole discretion of determining the best method of breeding such mare. If, however, the mare does not settle, the Breeder shall be held harmless. There will be no guaranteed of live foal for any mare leaving Double J Ranch before being checked 30 days safe in foal by the attending veterinarian.
9. Live Foal Guarantee. Live foal means the foal shall stand and nurse. It is understood that if the mare proves barren, aborts her foal, or if foal is stillborn, a return season will be guaranteed the following year only, providing proper notification is give. Proper notification shall be defined as follows: Written certification by a licensed veterinarian within seven days that the mare has slipped or produced a non-viable foal. Mare Owner certifies that such abortion or death did not result from any act or omission of the Owner subsequent to the mare's departure from Double J Ranch. Booster rhinopneumonitis vaccinations must be administered as indicated by the individual drug manufacturer as the mare progresses through her pregnancy. Failure to do this will void the Live Foal Guarantee.
10. The breeding season in force for this contract shall begin February 15th and close July 15th of the year dates on the contract.
11. It is further agreed that should the above named stallion die or become unfit for service, or if the above named mare dies during the breeding season, then the Mare Owner my substitute another mare or breed the above named mare to another stallion owned or managed by Double J Ranch that is agreed to by both the Mare Owner and the Breeder.
12. A breeder's certificate will be issued to Marc Owner after all expenses have been paid in full and upon notification of the birth of the foal.
13. Waiver of Liability. It is understood that the breeding farm, its owners, employees, and guests shall not be liable for any injury, escape, disability, or death of any horse on its premises. The above named Mare Owner, whose horse(s) is (are) under the care of Double J Ranch will not be liable or responsible for any damage, injury or death to the breeding farm stallions, employees, veterinarians, or other animals in the care of Double J Ranch, whether or not caused by his horse.
14. The signing of this contract entitles Double J Ranch to charge twelve percent annual interest on all past due invoices. Past due billing is defined as those amounts not paid within thirty days of invoicing.
15. This contract is governed by the laws of the State of Pennsylvania. All accounts due and payable in Lackawanna County, PA.
16. When the above named Mare Owner signs and returns this contract to the Breeder, it will be then a binding contract on both parties, subject to the above terms.
